Summary of terms for the Riksbank's six-month loans in SEK with auction on 8 October 2008

This is a summary of the terms. The complete terms are shown in Appendix A.

Loan via bid/auction.
The Riksbank's monetary policy counterparties in accordance with the Conditions for RIX and monetary policy instruments (the Conditions).
Swedish krona (SEK).
186 days.
SEK 100 billion.
SEK 500 million.
Bids should be in multiples of the minimum bid amount.
5 per institution.
25 per cent of the offering amount.
The interest rate indicated by the Riksbank in Saxess/OMFIE at page RIKO at the time the auction starts and comparable to the prevailing repo rate plus an addition of 0.40 percentage points.
To be expressed as a maximum of three decimals.
Wednesday 8 October, 9:30-11:00 hours (CET/CEST).



Bids shall include both amounts (SEK) and interest rates.
Bids are made by telephone +46-(0)8-696 69 70, and must be confirmed by fax +46-(0)8-787 01 69.
A bid made by telephone is binding and must be made prior to the end of the bidding period.
Bids are accepted from the highest interest rate and gradually lower. If several bids refer to the lowest interest rate accepted, then allocation will be pro rata.
The Riksbank reserves the right to allocate an amount that differs from the offered amount if the Riksbank considers there are special reasons for doing so.

Allocations will be rounded off to the nearest SEK million.

Tuesday 14 April 2009.
The lowest interest rate accepted will be applied to all counterparties who have been allocated a share in the auction.
